Terms and Conditions

1. Information on how to enter and prizes form part of these conditions of entry. Entry into the promotion is deemed acceptance of these conditions of entry. Entry is via automatic entry.
2. Entry is open to all permanent Australian residents. Directors, management, employees and their immediate families, dealers, printers, suppliers, contractors and agents of Budget Rent a Car Australia Pty Ltd are ineligible to enter.
